Work Session: Sewer Extension Project with Underwood Engineers and USDA

Announcement: There has been a lot of discussion in the community about the Sewer Extension project. The Select Board remains committed to working with its engineers and staff to gather all the facts and weigh out the options before making a decision. The Select Board appreciates all the feedback from community members who are still deciding, in favor of, or concerned about the project. We hear you and want to reiterate that we are still gathering the information, including visiting other communities with similar projects, to make an educated decision.

Today, the Select Board is having a Work Session with Underwood Engineers and USDA staff The Select Board does not take public comments during Work Sessions as it is our time to review presented information, ask questions to the presenters and think through its options. The Select Board is also considering hosting additional public information sessions in February/March to continue listening to the community.
